SEWER - SCHEDULE OF FEES AND CHARGES

Effective Date: January 1, 2025

I. CONNECTION FEES

A. Connection Fee:

- Authority-Installed Extensions
 - (1) Customer-Constructed (Per Connection) Actual Township Cost plus 10%
 - (2) Developer-Constructed (Per Connection) Actual Township Cost plus 10%
- Township Constructed Actual Township Cost plus 10%

B. Inspection Fee:

- Residential (Township) \$ 50.00
- Commercial (Township Engineer) Actual Township Cost plus 10%

C. Tapping Fee:

EDU = 150 GPD (average water usage, based on actual customer water meter readings)

- Capacity Part (Capacity Fee-Per EDU) \$ 3,448.00
- Collection Part (Main Line Installation Fee-Per EDU) \$ 645.00

Total Tapping Fee \$ 4,093.00

- Reimbursement Part As Required

II. SEWER RATES

A. For Metered Users of the Water System:

- Base Rate Per Month \$ 29.50
- Rate Per 1,000 Gallons Metered Water Consumption Per Month \$ 9.77

B. For Metered Users of the Sewer System:

- Base Rate Per Month \$ 29.50
- Rate Per 1,000 Gallons Metered Wastewater Discharged Per Month \$ 9.77

C. For Non-Metered Users:

- Minimum Bill Per Month (Based on 150 GPD Wastewater Discharged) \$ 74.44
Includes – Base Rate Per Month - \$29.50
Usage - \$44.94 (Rate \$9.77 - Per 1,000 Gallons Water Consumption)

III. MISCELLANEOUS CHARGES

- A. Service Lateral:
 - Repair Actual Cost plus 10%
 - Inspection \$50.00
 - Rpr./Inspect. – Pipe Bursting/Lateral Lining (Twp. Engineer) Actual Cost plus 10%

- B. Sewer Extensions:
 - Constructed By Township Design, Inspection & Construction Costs; Administrative Fees
 - Not Constructed By Township Plan Review & Inspection Fees

- C. Deduct For Uncontaminated Wastewater:
 - Rate Per 1,000 Gallons Metered Water (Up to 1 Year Period) \$ 9.77
 - Property Settlement – Report Meter Reading Five (5) Days Prior to Settlement

- D. Check/ACH Return Fee: \$ 50.00

- E. Payment by Loose and/or Rolled Coins (Per Roll) \$.50

- F. Administrative Fees:
 - Delinquency Notification \$ 25.00
 - Water Shut-Off Processing \$ 50.00
 - Lien Processing \$ 100.00

IV. INDUSTRIAL WASTEWATER CHARGES

- A. Industrial Wastewater Discharge Permit Application Fee \$ 500.00

- B. Industrial Pretreatment Inspection Actual Cost plus 10%

- C. Surcharge For Excess Strength Wastewater:
